THESE ASSISTANCE DOGS ARE TRAINED TO IDENTIFY THE SCENT OF THE CHANGING BODY CHEMISTRY OF THE CLIENT AND ALERT THEM OF THE ONSET OF HYPOGLYCEMIA (LOW BLOOD SUGAR), PRIOR TO BECOMING SYMPTOMATIC, THEREBY ASSISTING AND SAFEGUARDING THE DIABETIC WITH THEIR INSULIN THERAPY.

ADDITIONALLY, D4D CONTINUED TO STUDY THE IMPACT OF THE DOGS ON ITS CLIENTS, TO ENHANCE THE QUALITY OF ITS PROCESSES AND OUTCOMES.
